# MONTGOMERY ANCIENT MARINERS BOARD OF DIRECTORS MEETING SUNDAY, SEPTEMBER 31, 1995

# I. Call to Order

The meeting was called to order by President, Tom Denes, at 11 a.m. at his house. Fifteen board and regular members attended the meeting. A list of attendees follows at the end of these minutes.

# II. Old Business

- A. We reviewed the cash flow statement and statement of income and expenses from the Albatross Open. The cash balance on August 31, 1995, was \$3982; income for the year was \$2433 and expenses were \$1475, resulting in a net cash gain of \$958 and a remaining cash on hand of \$4940. Income for the Open totaled \$5701 and expenses were \$4462, resulting in a net gain of \$1239.
- B. Minutes from the last meeting were reviewed. It was noted that we are still waiting for information for a team banner to be displayed at meets. The minutes were approved.

#### III. New Business

A. Election of Officers and New Board Members: The following people were unanimously elected:

B. New Budget: The proposed September 1995-August 1996 budget was discussed. Under income, we noted that we could develop income from sponsors and advertisers for the Albatross Open. We discussed dues, and a motion was made, seconded and passed raising dues \$2. Members will now pay \$30/year, which includes Master's membership. We discussed income from the Open social and voted to raise entry charge to \$10; this will allow volunteers (full-time, non-swimming volunteers) to attend gratis and enable us to rent a facility and not impose on any member's home. Under expenses, we discussed the Open and costs associated with

medals and ribbons. It was pointed out that this year we will probably run a deficit. The new budget was passed and is attached to these minutes.

- C. Fun Meet: We are having a three-team fun meet Saturday, November 4 at Holton Arms school. Nancy Fox will talk to people about food to help ensure that at the social afterwards we have enough main courses; last year, we had enough brownies for about 500, with not enough substantive fare.
- D. Pool Management: We discussed the problems this summer with guards not showing up to open the Bethesda pool and what we can do to make sure this doesn't happen next year. We also discussed pool management at the MAC and noted that while we pay Premier Clinic, the parties accountable for daily operations are county employees. Jeff Roddin is looking into ways we can have an effective say on pool operations.
- IV. Meeting Adjourned: The meeting was adjourned around 1 p.m. The next meeting will be in January and discuss mainly the Open.
